WHERE TWO OR MORE ARE GATHERED TOGETHER, THERE I AM

The experiment that will be described took place in Bavaria, Germany, in the first week of June 1987. There were about thirty participants in a Bavarian Chalet and with these participants was a Roman Catholic Priest who attended the seminar with the group. The house was situated on the side of a mountain overlooking a valley with snow capped mountains in the background. Adjoining was the small town of Wagneritz.

The seminars were given throughout the day and in the evening a Mass was celebrated with us sitting in a circle around the priest. There was extensive singing, holding of hands and the reception of Communion. About 21 of the attendees had their own individual crystals, four, six, eight and twelve sided healing crystals. Two of them possessed Herkimer diamonds and one had a natural, single-terminated crystal. We decided to measure the fields that were in the crystals before and after Mass on the first day and after Mass on each subsequent day. The jug of water placed on the altar was measured along with the crystals. This was the first time, to the best of our knowledge, that an experiment of this type was done.

From the experimental work that we had done in our laboratory in San Jose, California, it was determined that a double-terminated healing crystal would resonate with the energies of a person once he had placed his vibration into a crystal. In other words, remote therapy

can be given to a person and this therapy can be followed precisely with the Omega 5 instrument designed and built by Daniel Perkins. The Omega 5 attributes numerical values to the forces that are contained in a crystal which has been held in the hand of an individual. We determined three different sets of values, namely:

OMEGA5 V

1. the numerical value of the geometric form of the device under consideration, 2. the charge transfer to the crystal of the fields contained within the body of an individual, and

3. the charge envelope which surrounds

the body of an individual.

When there is an interference with this charge, such as when food that is antagonisitic to the well-being of an individual is placed on his body, the charge level will drop down to a very low value, even to zero. When the food has beneficial value, the charge will be enhanced and will be duplicated to the same value as when the food is injested by eating. The third set of numerical values occurs when a person receives the thought of well-being and of wholeness, from a party who is projecting this to them. These sets of values deal with the transfer of the energetics of the thought of love and joy that are in the mind and heart of this person.

To recap:

1. The first set of values gives the geometric patterning of the object under measurement. The value we obtain from our double-terminated healing crystals is 454. This is true be it a four, six, eight or twelve-sided crystal. This

number exactly matches the value obtained when you measure pure water which has not received any special


which has not received any special treatment. When water and crystal have the same primary vibrational value (454), any charge applied to the crystal can and does transfer directly to the water

with no loss in vibrational activity.

2. The next set of values is the energetics of the fields that are stored in matter itself. At the moment I make no discrimination as to the secondary considerations of these fields. The normal vibrational levels that we encounter are in the three digit figure area. However an exception to these statements will be given very shortly. This number can be amplified by deep breathing, moving into the sunlight, drinking vitalized water, or consuming foods which are healthy for the body.

3. The third set of values deals with energies that are of a subtle nature. By subtle, we mean those forces which are capable of moving freely in and out of a physical body. These forces we may call etheric and are the building blocks of the powers used by mind in constructing thought-forms and maintaining the balance and totality of being of a human body. These statements are the product of the experimental research in our laboratory. The work is ongoing and developmental at this time. Let us now go back to what took place in Germany.

Each day we measured these values on the Omega machine using three people, a medical doctor, a physicist and myself. Our measurements concurred and were recorded. The real surprise took place between the third and fourth day where VALUES ROSE FROM THE




NORMAL three digit numbers to values

that were in the 1035 power.

Figure #1 shows the curve of the change which took place. In the majority of the people whom we measured, the energies within their crystals at the end of the fourth day was the same value as the water that was on the altar. From individual variations in numerical values, we all exhibited  $4(x10^{34})$  54 in all of the levels of measurement. The reading for water was  $4(x10^{34})$  54 which differed from the control's readings of a modest 454.


The individual crystals measured exactly the same as values we had in the water. The exception was the value we obtained with the Herkimer diamond and the natural crystal, both of which showed practically no amplification of the field even after four days of measurement. Two of the individuals with healing crystals had values which dropped on the second and third day and came back in harmony with the rest of the group on the fourth day.

A small sample of the water was bottled, returned to our laboratory in California, and was measured on Aug. The water exhibited exactly the same value that it had when measured with the Omega 5 in Germany, two months from the day of original testing. We then did an ultra-violet spectrophotometric assay for the structuring of this fluid and the result is shown in Figure #2. The change in ultra-violet absorbance is the highest we have observed in any sample we have treated to date. The normal values of structuring of water by a crystal are given in the diagram in Figure #3. You can observe how great the difference, is between them.

The water has stored a vital energy from the activities of the spiritual and religious services. It has maintained this and the product of this activity is a very precise, involved structuring of that fluid. The implication is that when spiritual, religious experiences are undergone, the energy that is created is stored in water, in rock, or in crystal which surround the ceremony. water then can have the potential of acting in a therapeutic manner. "Where two or more are gathered together there I am." The love of Christ can enter a group and change not only yourself but the matter that surrounds you, the water, the food and the very soil itself.

### MARCEL'S VISIT TO SEE DR. POPP IN KAISERLATURN, GERMANY

Dr. Popp is recognized internationally for his pioneering work in the quantitative measurement of light emitting from living cells. The emission of radiation is given the name of Biophotons. He has written many papers in this area and I had the opportunity of visiting with him and dialoging on this work on June 3, 1987. Dr. Popp's tests consist of taking a sample seed, putting it into a dark chamber, and measuring it with a special photomultiplier tube for a period of 2 to 308 seconds. He then takes the signals that are being emitted and puts them into a computer program to get a quantitative summary of the photonic emission of radiation that comes from a sample. The particular sample that Dr. Popp demonstrated was the use of germinated cucumber seeds which had never been exposed to light and kept in complete darkness in a closed container. They were then exposed to the photomultiplier tube and the light output measured. Graphs were made indicating

the light emission coming out of the seed. I took this seed that was in the chamber and gave it a charge with the eight-sided crystal. I tested the seed with the Omega 5 before and after the treatment. According to the Omega 5, the energy in the seed increased significantly. I said to Dr. Popp that this seed will have an increased output. The seed was again measured and the results showed that there was a twenty percent increase in total light output over the seed that was previously measured without a treatment. We attempted to reduce the light output with little success. It showed, from the first order of experimentation, that the intention of the mind of an individual can play a significant role in the activity of these types of experimentation. This was my intent in discussing with Dr. Popp at this time.

We discussed the instrumentation and his work. When time and money allows we will attempt to duplicate the instrumentation in our laboratory in San Jose. This was a pleasant, fruitful exchange of information and I hope we will be able to follow it up in the coming years with a significant sharing of data.

# EXPERIMENT NO. 58 SENSING RADIATION WITH THE THIRD EYE

Materials Required:
Household iron (hot)
Cardboard, 6" Sq., with a hole cut
in the center.

Have a person stand four feet away from the subject and about 6" from the iron, while holding the cardboard in front of the iron and moving it so that the hole focuses the energy within the circle at the site at the subject's third eye, and then move the hole around to see if he can tell when the thermal radiation heat is more pointedly directed at him.

Once you feel that radiation, take

your hand or any opaque source and flick it over your third eye, up and down or back and forth. You should start to see color. In other words, if you oscillate the infrared source, instead of just feeling pure sensation, you will see color corresponding to the rate at which your hand is oscillating.

EXPERIMENT #59 SEEING COLOR IN THE THIRD EYE USING A SPINNING DISC

Materials required:

Small electric variable speed motor or fan Thin cardboard or construction paper

Make a sector disc out of the motor or fan, cutting quadrants out of a piece of cardboard, or construction paper, so you have a sectioneded disk. Put it on the motor or fan at slow speed. your eyes and let the disk spin. Now try it with open eyes. You will go from sensation to color because you are getting a frequency in the process of "chopping off" that radiation. When you attain right rate of chopping, out comes the visible color. This is a first hand way of externalizing the ability to see not only vibration and feel it is as sensation, but to activate it into chromatic sensation by chopping, getting a certain frequency or beat to the radiation.

The next two experiments will deal with the expansion of the healing body. These experiments were designed to help to unfold the sensitive faculties which exist beyond the sense organs of touch, taste, sight, hearing and smell. Practicing these will allow the individual to expand himself beyond the limitations of physical organs.

## EXPERIMENT NO. 60 TOUCH

Materials Required:
Natural Quartz Crystal
Tape Recorder
Light source with red, yellow and blue gelatins.
blindfold

Hold the natural crystal and cover your eyes. Feel the sensations that take place in the tips of your fingers as you touch the crystal and try to experience the vibration that is inherent in the crystal. Breathe in, hold your breath, visualize the crystal with your mind's eye and touch it again to see the difference in feeling the crystal. Erase the crystal with the techniques that have been given in earlier newsletters. Touch and feel the crystal to notice any difference.

Record these sensations in your notebook. Place the crystal in a darkened room and again shield your eyes. Tape record your impressions. Have a person flash light unto the crystal and see if you can experience the difference with light or no light on the crystal. Then have the person project colored lights, into the crystal and see how you experience the variations in color.

#### EXPERIMENT NO. 61 TOUCH

Materials Required:
A meditation or healing crystal

Clear the crystal with pulsed breath and intention. Draw your breath in, hold it and bring the breath to equilibrium. Pass the index finger over the surface of the crystal. Record the sensations of touch that you are experiencing. Draw your breath in, hold it, visualize the crystal and release the breath. Become one with the crystal. Now test again the sensations that you experience when you pass the

finger over the surface of the crystal. When a proper communication is affected, a charge transfer takes place between you and the crystal and you can experience this charge on the surface of the crystal as a "stick." Draw your breath in and test the surface of the crystal. You will experience a change in the surface texture which comes back to normal (non-sticky) when you release your breath into the crystal. experiments help to evolve a dual sensitivity to both the texture of a surface as well as the charge capacity of that surface. Once these lessons have been experienced you can expand this to interpersonal relationships in knowing how to develop a loving, gentle touch, which is a means expression of your inner body.

## CHARGING A CRYSTAL by Bob Crane

The concept of "charging a crystal" with breath and intention is fundamental to transformational medicine and crystal therapy in general. On a recent "A.M. San Francisco," TV Show, a physicist correctly challenged Dael Walker's concept of charging a crystal. The physicist stated that it was not possible to do so because crystalline structures are so tightly bound that they do not readily allow electrons to enter. In other words, crystals cannot be charged with electrons and are actually electrical resistors.

The statement on the part of the physicist was correct as far as it went in defining the phenomenon of electric charge, but it also showed the limitations that modern science places upon itself even within the context of its own laws. There is a law of physics that allows a crystal to be charged with electromagnetic energy, although not with electrons per se. This law involves definitions of circularly polarized light (or any electromagnetic energy) that has been put through a crystal. When this

occurs, the layers of atoms within the crystal interact with the light and cause it to bend into a spiral form. Light is normally straight in its movement through space and its electric and magnetic fields cancel or are 180 degrees out of phase, so there is no apparent charge or magnetism. However, when this light is circularly polarized through a crystal it takes on a small electric charge and a small magnetic field.

The reason for this is complex, but involves the fact that as a light ray is curved, its electric and magnetic vectors (the direction of it's charged fields) point in and out of the circle of rotation, while in linear light these fields point up and down along the line of travel and cancel exactly. As the electromagnetic vectors oscillate in and out, the outward vector builds to a greater magnitude than the inward vector and a charge bias (the difference between these two quantities) develops. It is this charge bias that forms the basis of charging a crystal with

electromagnetic energy.

Once the crystal has been charged with electromagnetic energy, the atoms within it begin to vibrate and change the frequencies of this initial energy into their own frequency and energy patterns. These patterns are the basis of "patterned thought" which is then able to influence the DNA within the cells through resonance transfer. That is, the crystals resonate at certain frequencies and the cells pick up these frequencies because they are tuned to the crystalline matrix of atoms. It should be emphasized that the actual etheric fields of energy are not electromagnetic in nature, but electromagnetic energy, in conjunction with crystalline matrices, is able to access or reproduce them. Etheric fields are scalar or uncharged in nature and, as stated in a previous article, exist beyond the speed of light and form circles of potential energy.

The laws of physics not only allow for the charging of a crystal with the electromagnetic energy of circularly polarized light, but the magnitude of this energy is defined by equations. Approximately one million watts of power are needed to produce a magnetic field of one gauss in a crystal. It is known, however, that the body's cells may be influenced by magnetic fields of only one thousandth to one ten-thousandth of a gauss. This corresponds to circularly polarized energy of 100 to 1000 watts. This amount of energy is produced by many sources and types of equipment such as sunlight, televisions, stereos, microwave ovens, power lines, electric motors, etc.

The question is not whether or not electromagnetic fields influence the body, but which frequencies and fields are beneficial, which are harmful, and at what magnitudes do these effects occur?

In conclusion, a crystal may indeed be charged, even within the laws of existing physics, making it capable of exerting an effect on the etheric fields and living cells of a plant, animal or human body.

(Editor's Note: When we charge water by spinning it around a crystal, a magnetic field will develop in the water of .07 Gauss - M. V.)

Editor's Note: We had a typographical error in the first paragraph of our last issue (Vol.4 No.3) Marcel Vogel's article "Putting it All Together." "Simplifying" should have been "amplifying." Crystals themselves have no power, but are very precise, sensitive instruments designed to accumulate a charge from the body of the individual holding this crystal, amplifying the charge and feeding it back out through the crystal to a designated subject, through breath and intention.

CRYSTALS IN OUR PRESENT-FUTURE

Research into quartz crystals has shown that the benefits of their use in future technology for the planet will be of great importance. It has been shown by other inventors that a high voltage direct current, similar to those that Tesla was generating in Colorado, when grounded through a quartz crystal, causes the crystal to lose weight. In other words, a nullification of gravity-takes place. This implies the use of quartz (and other crystals) in gravity nullifying or free energy vehicles.

Other researchers have demonstrated free energy effects from the interaction of quartz with rotating magnetic fields. If you do not think that magnetism involves free energy, then take a magnet and move it over an iron object and watch it lift the object. This lifting is equivalent to energy (in terms of physics, energy equals weight times the distance raised), and the iron object may be raised thousands or even millions of times without any loss of magnetism in the magnet. This implies free energy, that is, as objects are lifted with a magnet, energy is stored in them, which is then released when they fall, without a corresponding decrease in the energy that is stored in the magnetic allignment of atoms within the magnet.

Because crystals may be grown from other crystals in conjunction with oscillating fields, a new basis for the material sciences has been created. In the future, most things will be constructed of crystallized materials. Large devices such as vehicles and machinery as well as small ones such as appliances will be constructed of crystal. The indestructibility of crystal (its long life and great structural strength) mean that products will have a life span, possibly into the thousands of years.

The most immediate application of crystal technologies, however, lies in the

field of the healing arts and of the purification of water and air through the interaction of crystals, acoustic and electromagnetic waves, and the substance that is in need of purification, whether it be a living cell or polluted water or air. Our research at P.R.I. is particularly concerned with this field. We have demonstrated that ordinary water may be changed in its intermolecular bonding structure so that chains of molecules are organized from ordinary, amorphous water. Once the chains are formed, impurities in the water are more easily precipitated out, as the chains tend to isolate them. Also, we believe that structured water will increase the rate of nutrient absorption by living cells because of the similarity between the water chain structure and the protein chain structures that exist within living cells.

The most important application of crystal, however, involves their connection to the super-physical, faster-than-light fields of energy that were discussed in previous newsletters. By organizing existing electromagnetic fields into precise geometrical configuration (identical to that of the lattice arrangement of atoms in a crystal) an energy equivalent or "mirror" image of matter in the form of energy is produced. This energy equivalent involves frequencies and velocities that are beyond those currently produced by the largest particle accelerators. They are attainable even within very small crystals (although at very small amplitudes) because crystals are resonantly tuned and modulated upward, while the physical approach that is used in particle physics involves only the very random use of energy to slam particles together. This results in virtually all of the energy being wasted.

Once the crystal has been activated with ordinary energy, it interacts with the dense ether and the very beneficial, high frequency energy that resides there is brought into this dimension where it is able affect matter, whether it is atomic, molecular, or cellular. dense ether was discussed by Oliver Lodge and other 19th century

physicists).

The greatest block to the realization of this technology currently resides within the theoretical structure of modern physics which is severely limited by such concepts as entropy, conservation of energy, the laws of thermodynamics, Ohm's Law of electrical resistance, and the Newtonian approach to the law of gravity and the overall

particle nature of matter.

But the barriers within science are slowly coming down if for no other reason than our basic need (desire?) for continued technological progress. Currently, the phenomenon of electrical superconductivity has scientists completely baffled, as it is a contradiction of Ohm's Law, but is in reality only another phenomenon of the organization of energy into precise harmonic and numerical sequences as it is pulsed through a crystal. Certain valence electrons will accelerate so rapidly up to the speed of light that they will actually move beyond this velocity and outside normal space and time and appear to move instantaneously beyond the speed of light to some other location within the crystal.

Modern physics has a problem with this explanation, as it is apparent that electrons are not able to move through crystals. However, these superconducting electrons are not moving through a crystal but toward the center of each atom. Electron velocities are increased within the normal atomic orbitals and they move inward toward the atomic nucleus of protons and neutrons. As they arrive at the nucleus, their velocities are beyond the speed of light and they suddenly disappear into a "black hole" at the center of the proton and reappear at the center of another proton which is located at a distance from the first one, i.e., they superconduct from one place in the crystal to another.

We will progress despite our current difficulties and limitations and the wonders of a new technology based on crystals will come within our grasp, but it appears that we must first deal with the problems of our limited concepts and ideas about the nature of physical reality.

THE ARK OF THE COVENANT AS AN ORGONE ACCUMULATOR by Norman Mikesell

The New American Bible translation: Exodus, IV Chap. 25 Plan of the Ark. "You shall make an ark of acacia wood, two and a half cubits long, one and a half cubits wide, and one and a half cubits high. Plate it inside and outside with pure gold, and put a molding of gold around the top of it".

From this description the Ark of the Covenant appears to have been an orgone accumulator box. The ark was a box of acacia wood and gold foil. Wilhem Reich developed orgone accumulator boxes that are generally made of layered organic material and galvanized steel wool. We have one in the lab at P.R.I. made of 12 layers of paper and aluminum foil. Reich found that the air in his accumulator was up to one degree

Celsius (°C) higher than the surrounding air. Orgone energy, which the box accumulates, can be measured on an electroscope, which detects static electricity when it is placed inside the box (Mann, 1973, pp.49-51, 59).

In an attempt to characterize orgone energy, I have measured three-day-old water from our Orgone accumulator several times. The water tests out to be unstructured, with a high dielectric conductivity, and little or no UV and IR absorption. Structuring with a crystal showed only half the UV and IR absorption you get from structuring non-orgone treated water. The high conductivity shows that orgone water is in a high energy, unbonded state, probably either a free radical or ionized state. We have found this same state of water as an intermediate state in the structuring of water with a crystal and light. One hour after light and crystal charging there is an increase in dielectric conductivity and IR absorption with no phase shift of the IR bands. The phase shift, indicating an ice-like hydrogen-bonding of structured water, occurs five hours after the initial charging.

Another indication of orgone water's unbonded, unstructured state is the crystallization ability of both types of water. Crystal activated structured water grows abundant, perfect crystals when a 0.01% silicic acid solution is dried on a slide. This same solution in control water grows no crystals, there is

just an amorphous mass of silica. A crystallization experiment done by Samuel Lentine showed that twenty minute, orgone-activated water grew large, jagged, sodium thiosulfate crystals while control water grew perfect-shaped, small crystals. Orgone water treated for forty minutes grew an amorphous mass of crystal (Lentine, pp.240 & 244).

Orgone water remains in an acid condition while structured water becomes very basic. Marcel's Holy water from Germany and Wes Hsue's Tibetian Shaman Spirit water were both produced by placing them on altars during a Roman Catholic Mass or a Shaman Ritual. Both of these waters showed a very high degree of structuring with high UV absorbtion. pH of the Spirit water changed from 6.28 to 7.23. Diluting this 1 to 10 with more purified water and charging with a crystal increased the pH to 7.55 along with an increase in conductivity. The UV absorbtion was equal to that of pure Spirit Water.

Highly oxygenated structured water has detectable amounts of hydrogen proxide (Forest, 1987, p.5) that is formed from two hydroxyl free-radicals. We are presently starting to test for this in our samples. I suspect the orgone water has an excess of hydronium ions. This would make it more difficult to structure than control water. If this turns out to be true in the tests of time, I have some speculations as to how orgone water collects hydronium ions and how structured water collects hydroxyl ions.

Philip Callahan shows that magnetoelectric monopoles are generated by the sun. South-pole monopoles combined with electrons are absorbed by paramagnetic rocks, soil, Irish stone round towers, pyramids, pyramid-shaped clay, obelisks, pagodas, sacred mountain tops and paramagnetic humans. North-pole monopoles combined with positrons are absorbed by diamagnetic plants, rocks and soil (Callahan, 1984, pp.103-109). I think that the diamagnetic organic material of the orgone accumulator collects North-positron monopoles. The water becomes diamagnetic with excess hydronium ions produced from the positrons, and has a counter-clockwise pendulum spin from the North-monopole and positron spins.

Structured water attracts
South-electron-monopoles which becomes paramagnetic through accumulation of hydroxyl ions from the excess electrons and aquires a clockwise spin from the South-molopole and electron spins. I think the counter-clockwise spin of orgone water attracts CO, and becomes

more acidic, while the clockwise spin of structured water absorbs oxygen from the air and becomes more basic with the formation of additional hydroxyl ions.

The Ark of the Covenant and orgone boxes are capacitors that store some kind of energy. What kind of energies and how they effect water are questions we are begining to answer. The healing effects of structured water and orgone water will one day be described in terms of the biophysical changes that each water brings about in a plant or body.
